AGM23-01 Call to Order & Introduction of Guests

A.S.A. President Dave LeGallais declared the meeting open for business at 13:08 hours, and welcomed all present – members, guests, Seniors Centre staff - to the 2023 Annual General Meeting of the Aurora Seniors Association. The President noted that there were 113 members present, which was a record, as the quorum for a members' meeting is 50.

The President also read the Town of Aurora Land Acknowledgement which states:

We acknowledge that in Aurora we are on the traditional and treaty territory of the Chippewas of Georgina Island, who are Anishinaabe peoples, and one of the First Nations reserves in Ontario. We are grateful to them for sharing their lands with us.

Noting the close and mutually beneficial relationship that AS.A. enjoys with the Town of Aurora, the President extended a warm welcome to Mayor Tom Mrakas, Robin McDougall, Director of Community Services and Lisa Warth, Manager of Recreation Services, and invited the Mayor and Robin to address the meeting.

Mayor Mrakas extended greetings on behalf of the Town and Council and acknowledged the mutual benefits that the strong partnership with A.S.A. contributes to the Aurora community and commended A.S.A. for providing activities and opportunities for older adults to stay active and socially connected. The Mayor also acknowledged the dedication and work done by the A.S.A. Board, volunteers and Town staff - Karie, Andrew, Bill and Brandie – particularly for their efforts to ensure continued support and services to the seniors community throughout the disruption caused by the COVID pandemic. On behalf of the Town and Council, The Mayor wished A.S.A. continued success and reaffirmed the Town's unwavering support.

As the A.S.A.'s direct liaison with the Town, Robin McDougall also commended the Board and membership for their dedication to maintaining a vibrant Seniors Centre as evidenced by the impressive attendance at the A.G.M. Robin thanked Town Staff for their resourcefulness in providing

complimentary programs and events. She also commended the Board for their collaborative relationship with the Town and welcomed the new 2023-24 Board.

The President thanked Mayor Mrakas and Robin McDougall for their comments and continued with the meeting agenda.

AGM23-04 Treasurer's Report & Approval of 2022 Financial Statements

In his remarks, Interim Treasurer Rob Ishoj noted:

"My name is Rob Ishoj. I am, until today's date, the Interim Treasurer filling in for Cheryl Rines, the outgoing treasurer. Cheryl cannot be here today due to a prior commitment outside of the province. I also sit on the Finance Committee. A summary of the activities of the Finance Committee over the past year is part of the agenda package.

The past 12 - 18 months have been difficult from many perspectives. The good news is that we're getting back to a more normal world. The Centre is open and activities are in full swing (and that's not just a pickleball pun!!).

The Association is in a strong financial position. Although we had a small loss in fiscal 2022, our balance sheet is solid, with more than adequate cash

and investment balances, liabilities all current and paid on a timely basis, costs in control and good post-Covid revenues."

The Treasurer introduced Andrea Nauss, CPA, the Senior Manager from BDO Canada LLP. whose team has reviewed the A.S.A. financial statements for fiscal 2022, to discuss the nature of a review engagement, the work done by her team and the statements themselves.

Andrea Nauss referenced the A.S.A. Financial Statements for Fiscal 2022, consisting of:

Andrea noted that her team had conducted the review engagement of A.S.A. Financial Statements as prepared by the A.S.A. Finance Committee and they did not encounter any significant difficulties significant deficiencies in internal controls, nor did they have any significant findings to report from the results of performing their procedures.

There being no questions from members, Rob Ishoj thanked Andrea for her report and presented the recommendation for the adoption of the Report and 2022 Financial Statements:

Vern Cunningham is the new chair of this committee and he and his group of enthusiastic volunteers are planning some wonderful events for all of us to enjoy. I have already mentioned volunteers a couple of times and that is because the A.S.A. simply would not function without them and we all owe them our gratitude. We have a wonderful group of volunteers taking on all sorts of tasks from working at the Reception desk to providing food and beverages at our Bistro and BBQ's, running programs and activities, helping with committee work and keeping our gardens looking so beautiful, to name but a few. accomplished quite a lot considering going through a world wide pandemic. It's so satisfying to see everyone returning to the Centre again. I have enjoyed my time immensely but it's time to pass the gavel on to new people with new and fresh ideas. I will continue on the Board for one more year to help in any way I can with the transition to this new Board. I want to thank all the people who served on the Board with me during this time and say that even when we disagreed on an item it was still a pleasure working with all of you. Thanks to all of the A.S.A. members for the tremendous support you always gave me. I look forward with excitement to the future of our great Seniors Centre."

AGM22-09 Seniors Co- ordinator's Report – Attached

Karie Papillon, Adult Programs Co-ordinator, thanked the Board and members for their support, and provided an overview of the programs and activities organized by Town Staff to complement A.S.A. activities:

- In September 2022 staff launched our first and highly successful postcovid Open House, Try It Week, A.S.A. Activity Fair and Seniors Active Living Fair.
- We also launched our weekly walking club titled "Walk, Strech & Learn". The program ran weekly at the Aurora Family Leisure Complex free walking track. In total we had over 600 participants for 26 weeks. This program was funded thanks to the Ontario Seniors Community Grant Program
- In October staff partnered with Arboretum volunteers for our first "Guided Stroll and Chat" through the Aurora Arboretum.
- Partnered with other Town of Aurora staff, York Central Fire Services, Aurora Public Library, York Regional Police and Chats to provide newcomer seniors a bus tour of Aurora.
- February 2023, staff launched the Older Adult's fitness playlist of free exercise videos on the Town of Aurora's YouTube page, funded by the New Horizon's for Seniors program.
- In March, thanks to funding from the New Horizon's for Seniors program we offered a free "taste of art program" to 50 participants
- We continue to offer Seniors Centre Without Walls.- free telephone and zoom based exercise and social programs - held 6 days a week. In 2022 we had over 5000 logins to zoom or the telephone. This program also won the Reader's Choice Award for favourite Adult Program in York Region. Thank you to those to nominated and voted for this program
- Twice a month we provide Seniors Centre in the Mail. Brandie carefully crafts an activity kit, and community information to be distributed available to Aurora residents and and non-residents. We distribute over 300 packages, every 2 weeks. We will deliver over 7000 packages in 2023.

- In 2022 we offered 154 registered programs. We continue to offer in person, virtual and hybrid classes. Of these 154 programs 19 were new offerings.
- 2022 saw us re-launch day trips. Andrew successfully offered 9 trips
- Staff also continue to participate in and assist with ASA Special Events, activity planning, marketing and ASA Fundraising efforts.
- Upcoming events: Open House week in September. Staff are also planning a Leisure and Volunteer Expo, Try It Week with over 15 activities and programs to try and our 7th Seniors Active Living Fair

Karie concluded her report saying: "We would like to thank the outgoing board members for all their support, especially over Covid. To our volunteers, THANK YOU. You make us smile, and happily help with everything and anything. We welcome our new board of director members, we look forward to accomplishing great things with you!"

Jim Abram, Nominations Committee Chair, took the podium and reported that:

"Your 2023 Election Committee members were John Scherrer, Cheryl Rines & Jim Abram as chair. I would like to thank all the volunteers that assisted at the election polls and those that assisted in tabulating the results.

Following the procedures for the Election of Directors, the Nominations and Election period was from March 3 to May 11 with the ballots being counted on May 12th.

Nine (9) members were nominated as candidates for the seven (7) vacated positions on the Board. Four of those Candidates are to be acclaimed. It is encouraging to see more members taking an interest in the leadership of our Association. Out of a membership of 1,253, 223 ballots were cast; representing only 17.8% of the membership.
